EBA Sectoral and Advocacy activities

EBA Executive staff attended the Revenue Policy Improvement Council meeting with the Minister of finance



The regular Meeting of the Extended Revenue Policy Improvement Council took place on December 22 at the RA Ministry of Finance.

The meeting was attended by representatives of the RA Ministry of Finance, the Ministry of Economy, the State Revenue Committee, the Deputy Chairman of the Standing Committee on Economic Affairs of the National Assembly, representatives of non-governmental organizations and well-known international consulting organizations included in the Advisory Council.

In his speech, the Minister of Finance of the Republic of Armenia Tigran Khachatryan stressed the need to discuss issues related to revenue policy within the Council.

During the sitting, the measures of the tax policy fixed by the program of the Government of the Republic of Armenia for 2021-2026 were discussed, as well as other issues related to the activities of the Council.

Following the meeting of the Extended Revenue Policy Council, it was decided to continue the discussions, assessing the impact of the proposed changes.

EU MS Economic Counsellors regular meeting took place with the EUD, EU MS embassy staff in charge of economic affairs, the European Business Association in Armenia and bilateral chambers of trade and commerce



During the **tour de table**, the EBA representative presented the progress made in the field of issuing residence cards for foreigners, in particular EU citizens. Later on, she introduced two projects currently implemented on bio-food and on creative industries, respectively with IT/ES and PL. She then communicated that two EBA partners would like to collaborate with the EU partners to import medical masks and create contacts with the Tours Agents of European

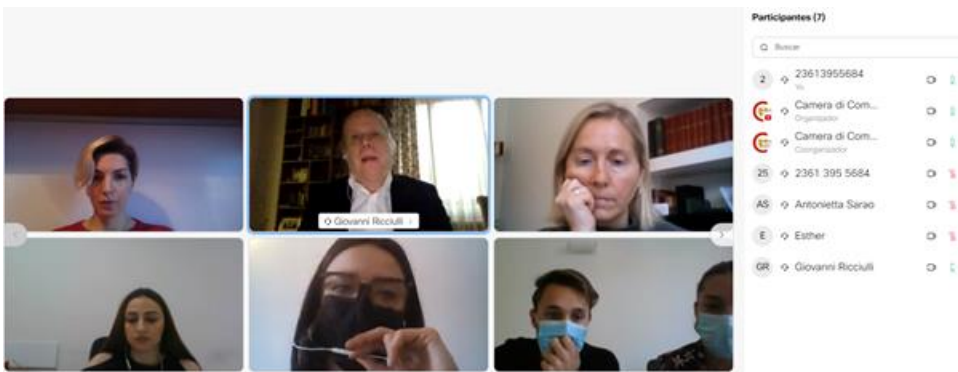
Countries. Main issues of EBA members have been presented, particularly issues related to public tenders and stability in the country.
