

BUSINESS BREAKFAST WITH GALAXY GROUP



European Business Association and Galaxy Group of Companies conducted a Business Breakfast "Prospects for the economic stability".

International and regional processes created new challenges for businesses, constraining them to implement strategies that would ensure companies' vision, while guaranteeing sustainable operations.

These issues were raised at the business breakfast event, co-hosted by Galaxy Group of Companies and European Business Association in Armenia.

"This meeting format is a great opportunity to identify the factors and conditions affecting the business environment in Armenia and to suggest a roadmap for economic development. Our goal is to consolidate efforts to explore the economic potential and to attract new investments," said Aram Khachatryan, Co-founder and CEO of Galaxy Group of Companies.

Vahan Dilanyan, CCO of Galaxy Group delivered opening remarks at the event, noting the strategy of the Galaxy Group in establishing partnerships and contributing to the economic development.

"This event is extremely important for establishing a

constructive dialogue between the public and private sectors. Nowadays, overcoming of main constraints for business is possible only with joint efforts," said Diana Sarumova, Executive Director of European Business Association in Armenia.

In her speech, she expressed her gratitude to representatives of public sector, diplomatic missions and international organizations accredited in Armenia, while highlighting the role of companies like Galaxy Group in the economic development of Armenia.

Deputy Minister of Economy, Armen Arzumanyan, welcomed participants of the meeting, emphasized the importance of this event and presented current activities and plans of the ministry for the business environment and investment climate improvement in Armenia. During the Q /A session he answered the questions of participants.

Edgar Karapetyan, Deputy CEO, Strategy and Innovation at Galaxy Group, presented effects of external shocks on the economy of Armenia.

During his speech Varoujan Avedikian, Managing Partner of TK & Partners, referred to the challenges of relocation, indicating the possibilities for overcoming them.

The competitive advantages of the investment environment in Armenia and the incentives in different industries were presented by Hovsep Patvakanyan, Founder at Investin.AM platform and the Head of EBRD Business Support Office in Armenia.

Elina Gabrielyan, Deputy CEO, Business Operations at Galaxy Group, spoke about the Group's investment projects and social-economic impact of last years.

CONSOLIDATION OF THE JUSTICE SYSTEM IN ARMENIA



The conference entitled "Judicial Reforms and Access to Justice" organised within the EU-funded project "Consolidation of the Justice System in Armenia" in partnership with the European Business Association (EBA) took place in Yerevan on July 21.

Head of the EU Delegation to Armenia, Ambassador Andrea Wiktorin and Deputy Justice Minister of Armenia Yeranuhi Tumanyants, made opening remarks at the conference.

"We need to continue our joint efforts and make sure that justice system in Armenia serves its citizens and businesses. It is equally important that we continue to create the best climate possible for growth and jobs in the Armenian economy," mentioned the Head of EU Delegation to Armenia, Ambassador Andrea Wiktorin.

In the opening speech of the forum, Deputy Minister of Justice Yeranuhi Tumanyants thanked the project team leader Peter Gjortler for the effective cooperation within the project and highlighted the support provided by the experts within the project in the direction of the reforms implemented in the field of

mediation and the assessment of the needs of establishing an arbitration center in Armenia.

During the conference, the results of the public opinion survey on Judiciary and Prosecution in Armenia have been presented. According to the survey, 65% of the population of Armenia consider that courts are characterized by professionalism and 66% attribute professionalism to the Prosecutor's office.

◆70% of respondents think that judges in Armenia are professional, and 74% consider judges polite.

- The public opinion survey has been conducted within the framework of the "Consolidation of the Justice System in Armenia" Project by the R Insights research company among 3,000 citizens during the months of April and May 2022.
- According to the same research, 52% of the population trusts the judicial system of Armenia for various reasons, 40% still do not trust the judicial system, and 8% of the respondents found it difficult to assess their level of trust in the judicial system. The average trus in the judicial system is 2.55 on a scale of 1-4.
- Despite growing trust in the judicial system, people's perceptions of finding justice in the courts remain a concern. According to 61% of Armenian citizens, people do not go to court because they have no hope of finding justice there, and according to 60%, the side that is financially more secure wins in court.
- According to the results of the same survey, 56% of the Armenian population trusts the prosecutor's office for various reasons, 32% of the respondents do not trust it, and 12% of the respondents found it difficult to assess their level of trust in the prosecutor's office.
- According to Expertise France representative Aurelia Schaf, one of the partners of the consortium implementing the project, the creation of stable evaluation tools for the courts will contribute to the increase of trust in the courts. "Evaluating the work of the courts will contribute to increasing public confidence in the justice system," Ms. Schaff noted
- Diana Sarumova, President of the European Business Association, referring to the reforms of the legal system and the correlation between economic investments, noted that an efficient legal system is one of the main priorities of foreign investors and the steps to be taken in the foreseeable future towards its further improvement are very important.
- Teresa Thalhammer, director of the "Consolidation of the Justice System in Armenia" project, also highly appreciated the joint efforts of the Armenian judicial system partners, noting that "The achievements of this project are the results of joint efforts of the project team and the justice institutions in Armenia. We experienced a very high commitment to reform the justice sector and we are convinced this will be guiding also in the future".

Business Access to Justice and Competition Law Procedure



The conference entitled "Business Access to Justice and Competition Law Procedure", organized on June 23 by the EU-funded project "Consolidation of the Justice System in Armenia" in close partnership with the European Business Association (EBA) and the Legelata Law Firm, was aimed at promoting dialogue between representatives of business and the justice system, as well as discussing issues of free competition in the market, violations of the dominant role, unfair competition and a number of other issues.

The forum was attended by the representatives of the justice system, business sector, international organizations, members of the Commission for the Protection of Competition as well as by ambassadors, and diplomats.

- "We need to continue reforms to make sure that the justice system in Armenia serves its citizens and businesses.
- And to make sure that we continue to create the best climate possible for growth and jobs in the Armenian

economy" said Silja Kasman, the Deputy Head of the Cooperation Department of the European Union Delegation to Armenia.:

In her opening speech, Deputy Minister of Justice Yeranui Tumanyants stressed the importance of holding such events in terms of conducting a dialogue with the business community to identify problems of the business community and find ways to solve them:

Ms. Tumanyants presented the steps aimed at creating an arbitration center by the Ministry of Justice, which are being implemented with the active support of international partners, as well as reforms in the judicial and anti-corruption spheres that will have a positive impact on the business sector:

Speaking about the importance of the Competition Law and access to justice Peter Gjortler the Team Leader of the EU-funded project "Consolidation of the Justice System in Armenia" mentioned that "Competition law constitutes an important foundation for the market economy, and it is, therefore, essential that both complaint and supervision procedures are available and effective. In this manner, competition law procedure forms an important part of the access to justice that is to be secured and enhanced by judicial reform."

The Commission for the Protection of Competition is making significant efforts to improve the competitive environment to achieve this goal, among other events, organizes events to raise the awareness of the general public and business representatives about the activities of the commission and legislative changes, said Tigran Markosyan, a member of the Commission.

Diana Sarumova, Executive Director of the European Business Association (EBA), speaking about the importance of fair competition, noted that this is the essential market driver and that organisational success will be driven by efficiency, innovation, and customer service.

"The Competition law should be designed to uphold fair play in business to stop companies with a strong position in a market, such as those with a monopoly, from abusing their position or making anti-competitive agreements, like cartels" mentioned Ms. Sarumova.

The forum participants noted that anti-competitive regulations in Armenia are quite strong. However, there are some regulatory grey areas, such as the implementation of the law as well as the proper monitoring and supervision of real shareholders and affiliated companies.

Speaking about the importance of such meetings, Gor Margaryan, Executive Manager of the Legalata Legal Firm, noted that "We believe that business-to-authority discussions as such, as well as the grounded feedback of the business, are essential to ensure the creation of the trust, a secure business climate, and understanding between both parties interested."
